- * This quotation will be evaluated in terms of the **80/20** preference point system as prescribed in the Preferential Procurement Policy Framework Act (No 5 of 2000) and for this purpose the original MBD 4, MBD 6.1, MBD 8 & MBD 9 forms must be completed and submitted together with your quotation if it is in excess of R 10 000.
- * A B-BBEE certificate must be submitted with your quotation.
- * The lowest or only quote will not necessarily be accepted.
- * **A valid original tax clearance certificate issued by SARS must accompany all quotations in excess of R 30 000 (if we have a Valid one, you do not have to submit it again, just indicate as such).**
